

**CAVALIER CLUB  
TRAVEL SERVICES AGREEMENT  
ELITE LEVEL**

UNIVERSITY OF VIRGINIA HOST PROPERTIES, INC., D/B/A BOAR'S HEAD RESORT, a Virginia stock corporation (the "Resort"), and \_\_\_\_\_ (the "Elite Level Member"), a resident of \_\_\_\_\_, enter into the following Agreement dated as of \_\_\_\_\_, 2019, and agree to the following terms and conditions:

1. Cavalier Club Terms:
  - a. Membership is for a twelve-month period from the later of the date this Agreement is signed, and the membership fee has been paid in full and is non-refundable.
  - b. The membership fee is due to Resort in the amount of \$1,199.00 at the signing of this Agreement. Failure to pay the membership fee, or cancellation of this Agreement as provided below, will automatically terminate this Agreement.
  - c. Elite Level Members will have the option to renew their membership on an annual basis at the current membership fee rate, discounted as determined by the Resort from time to time. Resort will send a renewal notice to Elite Level Member's address approximately forty-five days before the renewal date to offer the Elite Level Member the option to renew and to update any changes to this Agreement.
  - d. Elite Level Member will be issued one membership card that is to be presented when Elite Level Member takes advantage of Cavalier Club benefits. Membership cards are non-transferable, and a photo ID may be requested at any time the membership card is presented. Six additional "Associate Member" membership cards are available per Elite Level Member for \$25.00 each. Elite Level Member may register up to six Associate Members of his or her choosing by registering each Associate Member with the Resort. Associate Members are entitled to the same benefits as the Elite Level Member except as otherwise noted below. Vouchers, as described below, are only issued to Elite Level Members but may be transferred to and used by an Associate Members. Lost membership cards must be reported to the Resort and will be replaced for a \$25.00 fee. Membership cards are property of the Resort and must be returned upon request.
2. Elite Level Member and Associate Members are entitled to the following dining benefits:
  - a. **The Mill Room:** 35% discount on all meals, provided Member is accompanied by at least one, but no more than five, guests. Elite Level Member is also entitled to a one-time use voucher for 25% off dining for a group between ten and sixteen people. The voucher may be used only with an advance reservation.
  - b. **Racquets Restaurant and Birdwood Grill:** 15% discount on all meals. Member must be accompanied by at least one, but no more than nine, guests.
  - c. **Restrictions and exclusions:**
    - i. In-room dining, alcoholic beverages, and all purchases at the Deep End and Grab n Go, are excluded from all Cavalier Club benefits and are not subject to discount.
    - ii. Dining benefits are not available New Year's Eve, Valentine's Day, Mother's Day, Father's Day, Easter, Thanksgiving Day, Christmas Eve, Christmas Day, and UVA Graduation Weekend.
    - iii. The prevailing service charge will be calculated using the full, non-discounted dining bill and added to the Member's discounted dining bill when using Cavalier Club dining benefits.
3. Elite Level Member and Associate Members are entitled to the following hotel benefits:
  - a. **Complimentary Guest Rooms:** Elite Level Member is entitled to six one-time use vouchers, each good for a one-night stay in a guest room at the Resort. Reservations using a voucher may not be made more than thirty (30) days in advance. Vouchers may not be used for suites. Guest room vouchers may not be used Reunion Weekends, UVA Graduation Weekend, Move-In Weekend, Family Weekend, Homecoming Weekend, or UVA home football game weekends. This benefit may be used by an Associate Member or non-member if the Elite Level Member makes the reservation and the Associate Member or non-member presents the voucher at check in.
  - b. **Unlimited Guest Room Discount:** 20% off the best available room rate when booking rooms with the Resort. Each Member may reserve no more than three rooms per night and may not combine this discount with any other discount or promotion. Discounted rates are not available Reunion Weekends, UVA Graduation Weekend, and Family Weekend.

- c. **Priority Access to UVA Graduation Weekend Reservations:** Each Member will have access one week before the general public to make reservations for UVA Graduation Weekend. Each Member may reserve no more than three rooms for UVA Graduation Weekend.
  - d. **Restrictions and exclusions:**
    - i. Guest rooms are often pre-sold to full or high occupancy levels. Therefore, management reserves the right to restrict Cavalier Club program room benefits even though there may be some rooms available to reserve. Reservations made using guest room vouchers can be made no more than thirty days in advance and are subject to Cavalier Club availability.
    - ii. Cavalier Club room reservations are not available online. Cavalier Club complimentary rooms and discounted room rate must be booked by member by calling in-house reservations directly at 844-634-4260 and cannot be combined with any other discount or promotion.
4. Other Member Benefits:
- a. **Meeting Room Rental:** Elite Level Member will receive a one-time use voucher valid for \$500.00 off a meeting room rental at Boar's Head Resort for up to thirty guests and a one-time use voucher valid for \$1000.00 off a meeting room rental for thirty-five or more guests. Elite Level Member will also receive a one-time use voucher for a 10% discount off audio visual equipment rental, and a one-time use voucher for a complimentary bar set up fee. These benefits are not available Reunion Weekends or UVA Graduation Weekend.
  - b. **Retail Discount:** 15% discount on all items in the golf pro and spa shops. This discount cannot be used with any other discount or promotion and certain items may be excluded.
  - c. **Spa Discount:** 15% discount on all spa services. An advance reservation no more than thirty days in advance is required to qualify for the discount. This benefit is not available UVA Graduation Weekend. The prevailing service charge will be calculated using the full, non-discounted spa bill and added to the Member's discounted spa bill when using Cavalier Club spa benefits.
  - d. **Boar's Head Outfitters:**
    - i. 10% discount off any activity reserved in advance through Boar's Head Outfitters.
    - ii. 15% discount off the Spirits of Virginia Tour or Ancient Weaponry Experience with Boar's Head Outfitters for groups of 8 or more with an advanced reservation.
  - e. **Birdwood Golf Course:**
    - i. \$10.00 discount on the prevailing daily guest greens fees at Birdwood Golf Course. This benefit cannot be combined with any other discount or used to further discount late play greens fees.
    - ii. 10% discount on any individual or group lesson with any Birdwood Class "A" PGA or LPGA professional.
    - iii. 10% discount on play time in the indoor golf swing studio.
    - iv. Elite Level Member is entitled to pay the prevailing UVA Faculty/Staff discounted daily greens fee for an additional annual fee of \$500.00.
5. Other Terms and Restrictions:
- a. Boar's Head Resort shall not be liable for any amount greater than the membership fee to any member as a result of, or in conjunction with, his or her membership.
  - b. Membership card and/or photo ID must be presented in person to receive Cavalier Club benefits.
  - c. Resort reserves the right to make changes to the member benefits at any time but will provide Elite Level Member with written notice no less than thirty days before any changes to the terms of this Agreement become effective.
  - d. Cancellation policies for any reservations made to take advantage of Cavalier Club benefits will be provided to Member at the time of reservation.
  - e. Specific dates that benefits will be excluded will be communicated to Member as soon as possible and will be posted on the Resort website.
  - f. Resort reserves the right terminate membership at any time and the membership dues may be refunded at a prorated amount.
  - g. Members should allow for a ten-day processing time before benefits become available. Benefits are not retroactive.
  - h. Vouchers must be presented at time of use, may not be used after Member's membership is terminated or has expired, and will not be replaced if lost.
